# PANETTONCINO CLASSICO

## DESCRIZIONE / Description

Dolce lievitato naturalmente di forma tipica del panettone alto e la superficie con la caratteristica scarpatura. La pasta, di colore giallo è arricchita con uvetta Sultanina e scorze di arance candite.

Naturally leavened product, with the typical shape of panettone, and the surface is cutted with a typical cross cut. The dough is enriched with Sultana raisin and candied orange peel.

Farina di GRANO, Uva Sultanina (19%), Burro (LATTE), Zucchero, Tuorlo d'UOVO fresco, Lievito naturale (GRANO), Scorze di arance candite (6%) [Scorze di arancia (53%), Sciroppo di glucosio-fruttosio, Zucchero, Correttore di acidità: Ac. Citrico], Emulsionante: mono- e digliceridi degli acidi grassi di origine vegetale, Sciroppo di zucchero invertito, Sale, Aromi naturali.

WHEAT flour, Sultana raisin (19%), Butter (MILK), Sugar, Fresh EGG yolk, Natural yeast (WHEAT), Candied orange peel (6%) [Orange peel (53%), Glucose-fructose syrup, Sugar, Acidity regulator: Citric Acid], Emulsifier: mono- and fatty acid diglycerides of vegetable origin, Invert sugar syrup, Salt, Natural flavours.
